NEW PLAYER REGISTRATIONS

Additional players adding their name on 'Livescore' monitors will need to be clarified with administration if they are to become a registered player for that team. FINALS QUALIFICATIONS

Players listed on 'Livescore' monitors will be qualified for attendance at that particular game, even if they do not score or foul. Players that are not in attendance at the game will be removed from the 'Livescore' monitor by the referees. To be eligible for finals players must compete in seven (7) of the season's fixtured games.
